## Remarks

- 2) This is a perpetual annuity that continues to give a projected annual cash back of \$2,034.48 (Guaranteed : \$1,017.24 , Non-guaranteed : \$1,017.24) from 2056 – 2076 without continued payment of premium while surrender value increase approx. \$700 per annum.
